May 7, 2017

1. Reading by Nancy Britton to open the meeting at 12:25

2. M&C committee report. Charlene Ray gave report of the M&C committee. Report is attached.

Vince Buscemi's memorial is set for May 27<sup>th</sup> at 11:00, and those who wish to attend or bring food should rsvp to Pam Wood.

A retreat is scheduled for October 6 -8<sup>th</sup> at Stony Point.

3. The proposal to move September meeting from Labor Day Sept 3<sup>rd</sup>, to first day Sept 10<sup>th</sup> was approved by Friends.
4. A proposed letter of support for Neena Das was read on her conscientious objection status to accompany her application of citizenship. Discussion followed. Questions were raised. M&C will ask Nina to meet with them before the next business meeting. The report is attached.
5. Treasurer's report. Dan Seeger presented. Income to date has exceeded our expenses. Dan stated that auto transfers to MMM will help stabilize our cash flow. Dan will provide the information needed for those who wish to set up such a system of payment. Dan

reminded the meeting that last year the meeting exceeded its income. We have a pattern that income arrives late in December, and we do not know during the year what our cash flow will look like. Questions followed and Dan clarified the figures. The report is attached. Friends accepted the report.

6. Woodbourne State of the Meeting forwarded to NYYM a copy of the letter was read aloud to the meeting and was much appreciated. The letter is attached. We will acknowledge the receipt of the letter.
7. Space Committee report by Charlotte Ehrman. Charlotte stated that there was concern we do not have a contract for next year. Charlotte made contact with Richard Glassey from Riverside. Going forward, con-

tracts will only be on a yearly basis and will be renegotiated yearly. Questions and discussion followed. Friends accepted the report.

8. Announcements  
Cards for inmates at Woodbourne are available to sign at the rise of meeting. Several announcements were made. Dot raised the possibility of Friends meeting the other spiritual communities at Riverside and suggested that Riverside could organize such an event. Discussion followed as to possible occasions when these communities could meet. Bryan announced that Quarterly Meeting has a new web site: Nycquakers.org
9. Silence. The meeting concluded at 1:32 pm.

**Religious Society of Friends**  
**State of the Meeting for the Year 2016**  
**At Woodbourne Correctional Facility**

Challenge and Joys:

The preparative meeting at Woodbourne is relatively small, ranging from 8 to 13 members of diverse backgrounds in terms of religious beliefs, culture, ethnicity, and geography. Such diversity has enriched the life of the meeting. An increase in the willingness to listen to diverse views and experiences among members is noticeable. Members have been very supportive of each other through silent worship, prayer, and dialogue. Community volunteers have also been very supportive (spiritually and financially) as well.

Last year our meeting faced several challenges. However, in each of those challenges we found opportunities to forge a better relationship with the Light, each other, and those who live with us in the prison. In turn, these opportunities became a source of joy.

The New York State Board of Parole finally decided to release our longtime clerk Tony Singh, for whom a clearness committee was called to help him prepare for his parole interview. The queries posed during the clearness committee meeting prompted us to reflect about and grow from our particular situation. They were also an opportunity for each of us to strengthen our faith by assessing our spiritual life, pondering our past and present circumstances, and looking forward to a better future by rectifying current attitudes, habits, and actions that may stand on the path of spiritual growth.

The question over who should fill the clerk's position led to some dissent. As a result, a member decided to sever his ties to the meeting and stopped attending our Sunday meetings. We were hurt by this. However, encouraged by the wisdom of our volunteer members, it was decided to put aside personal preferences to appoint a registered Quaker for the vacant clerk position. The clerk's transition was not smooth, but it was a joyful success in the end. Regardless of the earlier differences of opinion at the meetings, members grew in their determination to strengthen their commonalities. In fact, a dissenter and the new clerk became better friends.

It was a great joy to see a friend, our longtime clerk, return to his home country of Guyana after decades of unnecessary imprisonment. Being able to celebrate Christmas in the company of outgoing volunteers and to share a meal with them was also a source of great joy.

The overall spiritual condition of the preparative meeting at Woodbourne can be summarized best in the words of one of our New York City volunteers: "I find the meeting to be healing." We agree.
